Rules & Regulations

How to enter

1. To be eligible for this contest, you simply have to thoroughly fill out the entry form posted on the **Spas Relais santé®** website at www.spasrelaissante.com.
2. Participants are entitled to enter the contest effective February 26th, 2010 at noon. The deadline for entries is March 31th, 2010 at 11:00 a.m.

Draw

3. The random draw and winner selection will be performed on March 31th, 2010 at 12:00 p.m. (noon), at the administrative office of **Spas Relais santé®**, 211, Place d'Youville, suite 04, Montreal, Quebec, H2Y 2B3, among all eligible ballots filled out on the **Spas Relais santé®** website by March 31th, 2010 at 11:00 a.m.
4. The individual on the winning ballot shall be notified in writing or on the phone by April 14rd, 2010. The letter will also include details on how to claim the prize. The winner will be asked to sign a declaration and renouncement form acknowledging his compliance with the contest rules and acceptance of the prize as awarded. The winner shall receive a gift letter confirming the prize.

The prize
